Why the change?

ShelterPoint has been offering the plan since the 70's. They served notice that they are withdrawing from this type of business going forward.

What is going to happen going forward?

As of July 1st, 2025 the district will be offering a new plan to retirees and active employees

What about claim prior to July 1st, 2025?

Claims can be submitted 12 months from date of service/appointment

Is the nature of the coverage changing and why?

Yes the coverage is changing. Our insurance agent could not find a vendor that would continue to offer the same types of coverage.



What does the new plan offer?

- 1.Accidental Insurance (AI) (Complete family)
- 2. Hospital Indemnity (HI) (Complete family)
- 3.Critical Illness (CI) (Complete family)
- 4.Accidental Death and Dismemberment (ADD) (Employee Only)
- 5.General Vision (supplemental)(Complete family)





Restrictions

Accidental Insurance (AI) (Complete Family)

All employees, active and retired must be under the age of 75 in order to enroll. Those all ready retired (retirement date prior to 7/1/2025) will have the option on a one time basis to enroll in this plan and JJ Stanis will invoice them. Future Retirees (those retiring after 7/1/2025) would be able to continue the benefit via the portability provision and the carrier will direct bill the member. Coverage may continue for 1 year after retired providing premium is paid.

Hospital Indemnity (HI) (Complete Family)

All employees, active and retired, must be under the age of 75 in order to enroll. Those all ready retired (retirement date prior to 7/1/2025) will have the option on a one time basis to enroll in this plan and JJ Stanis will invoice them. Future Retirees (those retiring after 7/1/2025 would be able to continue the benefit via the portability provision and the carrier will direct bill the member. Coverage may continue for 10 years after retirement providing premium is paid.

Critical Illness (CI) (Complete Family)

All employees, active and retired, must be under the age of 75 in order to enroll. Those all ready retired (retirement date prior to 7/1/2025) will have the option on a one time basis to enroll in this plan and JJ Stanis will invoice them. Future Retirees (those retiring after 7/1/2025 would be able to continue the benefit via the portability provision and the carrier will direct bill the member. Coverage may continue for 10 years after retirement providing premium is paid.

Accidental Death and Dismemberment (ADD) (Employee Only) - Retirees not Eligible

General Vision (supplemental) - Retirees are Eligible
